## SPECIFIC TERMS AND CONDITIONS – PROMOTIONAL CAMPAIGN – REFERRAL PROGAM

The Oncologist hereby agrees and understands that the M3India & its client Merck Specialties Private Limited have launched this Referral Program in the interest of the general public and do not have any control over the Referring Doctor sharing the information of the Oncologist with the patients.
- 8. M3India may suspend or terminate the Referral Program at any time with or without cause.

If M3 India modifies these Specific Terms, we will post the modification on the Platform, and such modification is effective upon posting.
